PROPOSED CALENDAR 2003 - 2004

Outline: This paper makes specific proposals for a schedule for The Global Fund for 2003 and 2004 as well as proposing a generic Calendar that would guide the Fund in future years.

Summary of Decision Points:

1. Decide that the Calendar as proposed for 2003 is appropriate and instruct the Secretariat to plan accordingly.
2. Decide that the generic Calendar is a good model for future planning and instruct the Secretariat to use this generic Calendar as a basis for planning.
