

## **Trustee Report**

February 29, 2004

## I. Introduction

This report provides an update to the Global Fund Board on the status of the Trust Fund 1. for the Global Fund (the "Trust Fund") through February 29, 2004.

## **II. Status Report on the Global Fund Trust Fund**

2. To date, the Trustee has negotiated and signed contribution agreements with 35 donors. These donors have made contributions totaling \$2,067.45 million. Details of the contributions received by donor are listed in Annex 1. Based on instructions received from the Global Fund, the Trustee has committed \$1,213.62 million of which \$249.25 million has been disbursed towards approved grants and \$74.45 million towards approved operating budget. Table 1 below provides an overview of Trust Fund activities and provides a breakdown by CY03 and CY04 up to February 29, 2004 in dollar terms. The summary of these activities in number of transactions are shown in Table 2 for the same periods. Annex 2 provides more detail on the operating budget.

4. Two contribution agreements are in process, for which Cash and Notes amounting to US \$ 116,324,800.00 equivalent has already been received by Trustee(refer to Table 3, item "d" above): the European Commission - Euro 42,000,000.00 and France - Euro 50,000,000.00 (in Promissory Notes). In addition, two more agreements are in process: Singapore – USD 1,000,000.00 and Barbados – USD 100,000.00.

## **III.** Continuing work with the Secretariat on Operational Issues

5. *Audit cycle*: In the October 2003 Trustee Report we informed the Board that the Trustee would be requesting an audit of the Trustee account covering the period July 1, 2003 to December 31, 2003 in order to make the future audit cycle of the GFATM Trust Fund correspond to the audit period of the Global Fund itself (i.e., on a calendar year basis). This six month audit was carried out in January and February 2004 by the auditing firm Deloitte & Touche, LLP. The audit was completed and signed off by Deloitte & Touche, LLP during the first week of March 2004 and a copy of the audited financial statement is enclosed herewith. The next audit of the GFATM Trust Fund will be for the calendar year 2004 (January 1 to December 31, 2004) and will be prepared in January/ February 2005.

6. *System development*: In the October 2003 Trustee Report, we also reported on the automated Business System development. In early March, the Trustee and secretariat staff met to review the automated business system development to discuss the system design. The objective of this discussion was to ensure that the design meets the current needs of the Global Fund and also has the flexibility to accommodate potential changes in the financial processes of the Trust Fund (e.g. changes in Phase 2 renewal process or the implementation of replenishment model).

7. Ongoing work program: In the coming months, Trustee will be working with the Secretariat to further refine the financial procedures including processes for suspension and cancellations of project grants as highlighted by the recent Ukraine case and for Phase II renewals. Furthermore, Trustee will continue to assist the Secretariat in developing the operational framework of funding that uses promissory notes and more generally operates under a replenishment model. Major movement in the US Dollar against other currencies has triggered the need to look for a mechanism to mitigate the effects of the foreign currency exposure to the Global Fund and the grant recipients. Trustee will assist the Secretariat in assessing alternative mechanisms and their feasibility.
