Portfolio Progress



- 419 grants signed in 127 countries
- \$ 5.2 billion committed
- \$ 3.8 billion signed

Portfolio Progress



- \$ 2.1 billion disbursed
- 62% of grant value over 66% of elapsed time
- Annual disbursement rate 94%

Phase 2 Renewals



- 131 recommendations approved by the Board
- 128 grants approved for Phase 2 funding
- Value of US \$1.4 billion
- 79 Phase 2 grant agreements signed


Phase 2 Renewals



- Intensive Workload
 - 49% approved as Conditional Go
 - 7 No Go recommendations processed under new procedures
- Secretariat Working Group for review of internal process
- No Go decision making procedures reviewed by PC

Round 5 Grant Signing

Round 5



- 63 proposals approved by the Board
- 4 appeals successful
 - Philippines TB
 - Sudan (northern sector) HIV/AIDS & TB
 - Equatorial Guinea malaria
- 17 grants signed to date

Round 5



- Preparatory work
 - 100% TRP clarifications completed
 - 75% LFA assessments completed by end April
- Targets/forecasts:
 - 37% signed by end April
 - 71% signed by end May
 - 82% signed by end June
 - All within 12 month deadline

- Recruitment for TRP & Support Group
- Issues addressed during PC Report to the Board

EARS Status



- Improved implementation of system after consultation with internal & external partners
- Response organised through:
