## TRUSTEE REPORT

**Outline:** This report provides an update to the Global Fund Board on the financial status and management of the Trust Fund for the Global Fund to Fight AIDS, Tuberculosis and Malaria (the "Trust Fund") through the end of March 2007.



# **Trustee Report**

## I. Introduction

1. This report provides an update to the Global Fund Board on the financial status and management of the Trust Fund for the Global Fund to Fight AIDS, Tuberculosis and Malaria (the "Trust Fund") through the end of March 2007. Section II provides information on donor contributions, investment income, grant commitments and disbursements and funds available for commitment. Section III provides an update on several financial management aspects of the Trust Fund. Section IV provides an update on the ongoing joint effort of the Global Fund and the World Bank on the issue of coordination and alignment

## II. Financial Status Report on the Global Fund Trust Fund

2. **Donor Contributions and Investment Income**: The level of donor contributions has surpassed the \$7 billion mark, reflecting the donors' continued support and strong commitments to the Global Fund's objectives. As of March 31, 2007, the Trustee has worked with and signed contribution agreements with 47 donors<sup>1</sup> with total contributions received, in cash and promissory notes, of \$7.12 billion. Details of contributions received, by donor, are listed in Annex I. Contributions received during the first quarter of calendar year 2007 totaled \$367 million. In calendar years 2006, donor contribution payments were \$2.02 billion, representing an increase of approx 43% over the annual contributions received during the last two years is shown in the Table 1 below.

<sup>&</sup>lt;sup>1</sup> The actual number of donors that have contributed to the Global Fund is greater than 47 because the UN Foundation and WHO receive contributions from individual donors, and the RED initiative contributes funds from all eligible transactions. These contributions are pooled and paid to the Trust Fund by the UN Foundation, WHO and the Global Fund in accordance with their respective contribution agreements with the Trustee.

3. In addition to contributions received in cash and promissory notes, as of March 31, 2007, the Trust Fund holds a total of \$547 million in receivables from signed contribution agreements, of which \$147 million is due to be paid in 2007, \$165 million in 2008 and \$235 million thereafter. Details of these contribution receivables by donor are listed in Annex II.

4. From inception through March 31, 2007, the Trust Fund has earned a total of \$301 million in investment income. Of this, \$126 million was earned during calendar year 2006. During the first quarter of calendar year 2007, the Trust Fund earned \$44 million in investment income. The annualized average yield for calendar year 2006 was 4.5% as compared to annualized average yield of 2.4% for calendar year 2005. The recent increase in the average yield reflects positive changes in the market conditions that determine the investment return of the Trust Fund.

5. **Grant Commitments and Disbursements**: The Trustee commits and disburses funds based on instructions received from the Global Fund. Since inception, the Trustee has committed: (i) \$5.6 billion for project grants, of which \$3.47 billion has been disbursed to Principal Recipients<sup>2</sup> (see Annex III), and (ii) \$383 million towards approved operating budgets, of which \$311 million has been disbursed (see Annex IV). Both commitments and disbursements continue to show an upward trend. During the calendar year 2006, the Trustee made grant commitments of \$1.8 billion and disbursed \$1.3 billion to Principal Recipients, as compared to \$1.5 billion and \$1 billion respectively during the calendar year 2005. Commitments and disbursements for project grants during the first quarter of calendar year 2007 were \$250 million and \$239 million respectively.

6. Commitments for project grants in EUR: Commitments for project grants denominated in EUR continue to be limited. From inception, the Trustee has made grant commitments of  $\notin$ 124 million, representing approx 3% of total project grant commitments. As of March 31, 2007 a total of  $\notin$ 46 million had been disbursed to Principal Recipients. The Trustee has not made any new commitments towards project grant denominated in EUR under Round 6 approvals. The Trustee continues to work closely with the Secretariat to determine the portion of Trust Fund balance to be held in EUR to match the project grant commitments in EUR. As of the date of this report, the amount of cash and promissory notes balance in EUR is well above the amount required to cover existing approved commitments for EUR grants.

7. As a reflection of the growth in the Global Fund's operations, during calendar year 2006 the Trustee received and processed 204 commitment requests and 678 disbursement requests, representing 35% and 38% of the total number of commitment and disbursement transactions respectively. As of March 31, 2007, the Trustee has received and processed 591 commitment requests and 1,924 disbursement requests from inception.

Since the Trustee only disburses to Principal Recipients and designated third parties, these disbursement figures do not measure subsequent expenditures for the specific project activities.


8. Funds Available for Commitment: Table 2 provides the current status of funds available for commitments based on contributions received, investment income, signed grant agreements and approved operating budgets.<sup>3</sup> As of March 31, 2007, net funds available for commitment towards new project grants and other expenses amount to \$1.2 billion and €184 million. Taking into account:

(i) \$310 million and  $\notin$ 179 million in pending contributions from existing signed contribution agreements and

(ii) \$160 million in approved Round 1 through 6 proposals that have been signed into grant agreements but not yet submitted to the Trustee for commitment (i.e., the value of in-process grant commitments),

net funds potentially available for commitment for new grants (including Board-approved proposals) and operating expenses total \$1.84 billion.<sup>4 5</sup>

### **III.** Other Financial Items

### 10. **Resource Mobilization**:

(a) <u>Investment Income</u>: As part of its work over the past months, the Resource Mobilization Task Team (RMTT) considered investment income earned on the resources of the Global Fund Trust Fund. The RMTT recommended that the Global Fund pursue a more diversified and aggressive investment strategy used to manage the Global Fund's cash balance as overly conservative. At the Finance and Audit Committee (FAC) meeting in March 2007, the Trustee made a presentation on the RMTT recommendations. The Trustee noted that the Global Fund differs, fundamentally, from endowments, and that its investment strategy should be aligned with the appetite for risk established by the Global Fund Board. The Trustee welcomes the recommendation that a working group of FAC, supplemented by external experts, be appointed to fulfill the investment committee role recommended by RMTT on an exploratory basis.

(b) <u>Restricted Contributions</u>: As discussed at the FAC meeting in March 2007, the Trustee understands the desirability of accepting restricted contributions for the purpose of fund-raising. However, the Trustee notes its concerns about potentially weakening the Global Fund's principled position against accepting earmarked funds, as well as the added complexity, in terms of tracking,

control and fiduciary management of restricted contributions. The Trustee appreciates the FAC's desire for careful consideration of the opportunities, risks and transaction costs of restricted contributions, and relies on the assurances in the proposal that restrictions will be tracked not by the Trustee but by the Secretariat.

11. The use of promissory notes by donors for their contributions to the Global Fund remains very limited. To date, only France and the United Kingdom have paid their contributions to the Global Fund in the form of promissory notes. As of March 31, 2007, the outstanding promissory notes are EUR 171.75 million from France and GBP 100.4 million from the United Kingdom.

12. In accordance with the Trustee agreement, a financial audit of the Trust Fund is conducted annually on a calendar-year basis to correspond to the calendar-year basis of the Global Fund's audit. The Trust Fund audit is closely coordinated with the audit of the Global Fund itself. The financial statements of the Trust Fund as of December 31, 2006 were prepared on the basis of International Financial Reporting Standards (IFRS) and audited by independent auditors Deloitte & Touche LLP. The auditors' opinion states that the financial statements were fairly presented in all material respects and are in conformity with IFRS. No issues were noted. Copies of the fully audited financial statements of the Trust Fund will be available at the Board meeting.

## IV. Coordination and alignment between the World Bank and the Global Fund

13. As a follow up to the recommendations of the Global Task Team (GTT), the Bank has been given the responsibility within the UNAIDS division of labor to lead the UN effort to assist countries in developing prioritized, evidence-based costed strategic plans and annual action plans. A facility, the AIDS Strategy and Action Plan (ASAP) service has been established at the World Bank on behalf of UNAIDS. The ASAP has been responding to country requests for assistance to develop national strategic plans which is one of the criteria for the "Three Ones" and making the money work at country level. The services offered have included organization of peer reviews of draft national strategies; provision of technical and financial support to assist countries and regions to strengthen their strategic response to HIV/AIDS; development of and sharing tools to assist countries in their strategic planning work; and beginning the process of capacity building for policymakers and practitioners in strategic planning to strengthen the response to HIV/AIDS. In this effort the World Bank has been collaborating with all partners including the Global Fund. ASAP began operations in June 2006 and is currently assisting 26 countries. This exceeds the goal established by the GTT of assisting 15 countries over the period 2006-2007 to enhance their HIV/AIDS strategies and 28 countries over two years to establish or improve annual action plans. In addition the Bank is also working very closely with the Global Fund on the Global Joint Problem-Solving and Implementation Support Team (GIST), and on monitoring and evaluation.

14. On April 24, 2007, the Bank will present a new Health Sector Strategy to its the Board of Directors for consideration. The Health strategy gives strong emphasis to enhancing World Bank support for health system strengthening and lays out the approach planned. It also reaffirms the Bank's Global HIV/AIDS Program of Action (published December 2005) which laid out the strategic areas of focus for the Bank's support for HIV. The Bank's Acting Director for Health, Nutrition and Population in the Human Development Network presented the new strategy to members of the PSC in March 2007.
