I. Introduction

1. This report provides an update to the Global Fund Board on the financial status and management of the Trust Fund for the Global Fund to Fight AIDS, Tuberculosis and Malaria (the “Trust Fund”) through the end of October 2007. Section II provides information on donor contributions, investment income, grant commitments and disbursements and funds available for commitment. Section III provides an update on several financial management aspects of the Trust Fund. Section IV provides an update on the ongoing joint effort of the Global Fund and the World Bank on the issue of coordination and alignment

II. Financial Status Report on the Global Fund Trust Fund

2. **Donor Contributions and Investment Income:** Donors have continued their support and commitment to the objectives of the Global Fund by increasing their contributions to the Global Fund. As of October 31, 2007, the Trustee has entered into contribution agreements with 47 donors¹ and received contributions in cash and promissory notes, of \$9.08 billion². Details of contributions received, by donor, are listed in Annex I. Contributions received during calendar year 2007 through October 2007 totaled \$2.33 billion, exceeding the total contributions received during calendar year 2006. The quarter-by-quarter pattern of contribution receipts for the last three years is shown in the Table 1 below.

¹ The actual number of donors that have contributed to the Global Fund is greater than 47 because the UN Foundation and WHO receive contributions from individual donors, and the Product (RED) initiative contributes funds from all eligible transactions. These contributions are pooled and paid to the Trust Fund by the UN Foundation, WHO and the Global Fund in accordance with their respective contribution agreements with the Trustee.

² The total represents contribution receipt of USD 8.62 billion plus USD equivalent of EUR 322.75 million valued on the basis of the exchange rate as of October 31, 2007.

3. In addition to contributions received in cash and promissory notes, contributions are receivable from donors based on signed contribution agreements. As of October 31, 2007, the Trust Fund holds a total of \$635 million in these receivables, of which \$11 million is due to be paid in 2007, \$170 million in 2008 and \$454 million thereafter. Details of these contribution receivables by donor are listed in Annex II. The Trustee is currently working with donors on finalizing additional contribution agreements totaling \$322 million.

4. During calendar year 2007 through October 2007, market conditions influencing the investment returns of the Trust Fund have been favorable. Investment income of \$167 million for the ten month period ending October 2007 reflects these positive market conditions. The annualized average yield for calendar year 2007 currently stands at 6.09%. From inception through October 31, 2007, the Trust Fund has earned a total of \$424 million in investment income.

5. **Grant Commitments and Disbursements:** The Trustee commits and disburses funds based on instructions received from the Global Fund. Both commitments and disbursements continue to increase. Commitments and disbursements for project grants for calendar year 2007 through October 2007 were \$1.49 billion and \$1.33 billion respectively. During calendar year 2007 through October 2007, the Trustee has made grant disbursements of \$1.33 billion as compared to \$1.32 billion of grant disbursements during the entire calendar year 2006. Since inception, the Trustee has committed: (i) \$6.83 billion³ for project grants, of which \$4.56 billion⁴ has been disbursed to Principal Recipients⁵ (see Annex III), and (ii) \$383 million towards approved operating budgets, of which \$356 million has been disbursed (see Annex IV).

6. Commitments for project grants in EUR: From inception, the Trustee has made grant commitments of €180 million, representing approx 4% of total project grant commitments. Since the beginning of calendar year 2007 through October 2007, the Trustee has made grant commitments of €55.58 million. This reflects a moderate increase in EUR commitments when compared with EUR commitments made in the previous calendar years. As of October 31, 2007 a total of €80.5 million has been disbursed to Principal Recipients. The Trustee continues to work closely with the Secretariat to determine the portion of Trust Fund balance to be held in EUR to match the project grant commitments in EUR. As of the date of this report, the amount of cash and promissory notes balance in EUR is above the amount required to cover existing approved commitments for EUR grants.

7. In terms of the volume of transactions, to date the Trustee has received and processed 779 commitment and 2506 disbursement requests. Again, reflecting the growth in operations, the Trustee received and processed 164 commitment requests and 680 disbursement requests since the beginning of the calendar year 2007, representing a steady increase over calendar year 2006.

⁵ Includes disbursements made to designated third parties as instructed by the Global Fund. Since the Trustee disburses only to Principal Recipients and designated third parties, these disbursement figures do not measure subsequent expenditures for the specific project activities.

8. **Funds Available for Commitment:** Table 2 provides the current status of funds available for commitments based on contributions received, investment income, signed grant agreements and approved operating budgets.⁶ As of October 31, 2007, net funds available for commitment towards new project grants and other expenses amount to \$2.08 billion and €151 million. Taking into account:

- (i) \$531 million and €72.5 million in pending contributions from existing signed contribution agreements,
- (ii) \$338 million in approved Round 1 through 6 proposals that have been signed into grant agreements but not yet submitted to the Trustee for commitment (i.e., the value of in-process grant commitments) and
- (iii) \$1.52 billion in approved proposals for which the Secretariat is in the process of signing grant agreements with Principal Recipients (i.e., the value of potential commitments),

net funds potentially available for commitment for new grants and operating expenses (including Board approvals) total \$1.07 billion.⁷

III. Other Financial Items

10. Resource Mobilization:

(a) Investment Income: The Trustee, as a member of the Finance and Audit Committee (FAC) will work closely with the investment management sub-committee in exploring investment management options to optimize investment returns in the light of increasing liquidity levels, consistent with best practices of publicly funded institutions.

(b) Debt2health: The Trustee has worked closely with the Secretariat in negotiating the first Debt2Health contribution agreement between the Republic of Indonesia, the Trustee and the Global Fund. The agreement is expected to be finalized soon. Under this arrangement, the Trustee will receive contributions from the Republic of Indonesia as a donor to the Global Fund. Under the separate Debt2Health agreement between the Republic of Indonesia, the KfW and the Global Fund, the Secretariat will follow up on the financial commitments of the Republic of Indonesia under the Debt2Health arrangement.

11. The use of promissory notes by donors for their contributions to the Global Fund remains very limited. To date, only France and the United Kingdom have paid their contributions to the Global Fund in the form of promissory notes. As of October 31, 2007, the outstanding promissory notes are EUR 185.75 million from France and GBP 140 million from the United Kingdom.

IV. Coordination and alignment between the World Bank and the Global Fund

12. Supporting stronger national AIDS strategies. The work of the AIDS Strategy and Action Plan (ASAP) service, established at the World Bank on behalf of UNAIDS at the recommendation of the Global Task Team (GTT) to support countries to develop more prioritized, evidence-based costed strategic HIV plans and annual action plans, is ever more relevant and important in light of the Global Fund's intention to invite countries to submit national strategies as the basis of proposals for funding. A recently completed independent evaluation of the first year of operations of ASAP was discussed with a GF representative and other stakeholders in October 2007. ASAP has met the expectations in its Business Plan 2006-07 in quantity and quality of its work. Key achievements include: (i) in response to country requests, ASAP has provided support for developing 29 AIDS strategies and peer review of 15 draft strategies; (ii) a Strategy Self-Assessment Tool and Guidelines, revised after pilot use and feedback from stakeholders, reflects good consensus on criteria for sound AIDS strategies, and is a simple strategy assessment tool; and (iii) an extensive capacity-building program on developing strategic plans is being rolled out, and will need to be expanded to meet high demand from countries and partners. The independent evaluation noted that it is too early to assess ASAP's impact on the quality of strategic and action planning, but suggested this as the focus for the next review. The consensus of the stakeholder meeting was that ASAP should adapt its roles and operating principles to reflect the evolving global environment (the move from project to program funding) and expanding country needs; and that ASAP needs to **expand** the scope of its service provision and **evolve** its operating approach to be even more responsive to country needs.

13. Monitoring and Evaluation: Coordination and alignment on Monitoring and Evaluation has made good progress. In April 2007, the Global Fund and World Bank met in Atlanta with other key monitoring and evaluation (M&E) partners to agree on a path forward to provide M&E capacity-building to help countries meet the "third One". The partners agreed to share assessment reports and deliver programs in a coordinated way. The Global Fund and World Bank conducted two recent joint missions to assess progress on the ability of the governments of Rwanda and Tanzania to report on key HIV/AIDS performance indicators. The Director of M&E at the Global Fund and the Coordinator of GAMET (the Global AIDS M&E Team) at the World Bank have regular monthly telephone calls to discuss issues and ways to work together more harmoniously.

14. Operations: The Bank continues to work closely with the Global Fund on the Global Joint Problem-Solving and Implementation Support Team (GIST), and the World Bank Director, Global HIV/AIDS Program, is just beginning a six-month secondment as Acting Director of Global Fund Operations, at the Global Fund's request. In addition to providing direct support to the Global Fund, this should facilitate continued improved coordination and alignment in future.
