# **Trustee Report**

November 2008

#### I. Introduction

- 1. The World Bank has been acting as the Trustee for the trust fund (the "Trust Fund") for the Global Fund to Fight AIDS, Tuberculosis and Malaria (the "Global Fund") since the Global Fund was set up in 2002. At each meeting of the Board of Directors of the Global Fund, the World Bank, as Trustee, provides an update on the financial status of the Trust Fund, and an update on the ongoing joint efforts in coordination and alignment between the Global Fund and the World Bank.
- 2. This report provides an update on the financial situation of the Trust Fund through September 30, 2008. Section II provides information on the changes in donor contributions, investment income, grant commitments and disbursements and funds available for commitment. Section III provides an update on several financial management aspects of the Trust Fund. Section IV provides an update on the ongoing joint efforts of the Global Fund and the World Bank on the issue of coordination and alignment.

# II. Financial Status Report on the Global Fund Trust Fund

3. **Donor contributions** continue to increase as a reflection of donors' continued support and commitment towards the objectives of the Global Fund. As of September 30, 2008, the Trustee has entered into contribution agreements with 48 donors¹ and has received contributions of USD 11.82 billion² in the form of cash and promissory notes. Details of contributions received, by donor, are listed in Annex I. Most annual contribution payments were received during the third quarter of the calendar year. Contributions received during the first three quarter of calendar year 2008 totaled USD 2.17 billion. The quarter-by-quarter pattern of contribution receipts for the last three years is shown in the Table 1, below.

These contributions are pooled and paid to the Trust Fund by the UN Foundation, WHO and the Global Fund in accordance with their respective contribution agreements with the Trustee.


- 4. **Donor contributions receivable** represent pledges confirmed by donors pursuant to signed contribution agreements with donors. Contributions are paid either immediately upon signing of the contribution agreement or paid over time in accordance with the agreed payment schedule. In addition to contributions received in cash and promissory notes, as of September 30, 2008, the Trust Fund holds a total of USD 990 million in these receivables, of which USD 65 million is due to be paid in 2008, USD 412 million to be paid in 2009 and USD 513 million thereafter. Details of these contributions receivable by donor are listed in Annex II.
- 5. **Investment income** earned during the first three quarters of calendar year 2008 totaled USD 141.69 million and EUR 5.36 million. The annualized yield for the first three quarters of calendar year 2008 was 4.42% for USD portfolio and 5.93% for EUR portfolio. Since inception through September 30, 2008, the Trust Fund has earned a total of USD 628 million and EUR 14 million in investment income.
- 6. The funds of the Global Fund Trust Fund held in trust by the World Bank are commingled with other trust fund assets administered by the World Bank Group in an investment portfolio (the "Pool"). The Pool is sub-divided into sub-portfolios ("tranches") to which allocations are made based on the investment strategy of each fund. The objective of the investment portfolio strategy is to maintain adequate liquidity to meet foreseeable cash flow needs, preserve capital (low probability of negative total returns over the course of a fiscal year) and maximize investment returns.
- Recent global financial turmoil has had a negative impact on investment returns for funds held in Trust by the World Bank, including the funds of the Global Fund Trust Fund. Turmoil in the financial markets has resulted in reduced market liquidity and substantial credit spread widening. Negative headlines from financial institutions are causing further pressure on credit spreads. The World Bank Treasury Department, which manages the Pool's investments, has been taking active steps to minimize the impact of the current global financial situation on the funds invested in each of the Pool's tranches. The strategy includes lowering the Pool's counterparty exposure to Commercial Banks by moving funds out of cash holdings and into government bonds. Also, adjustments were made at September month-end to shorten duration in select portfolios to keep within compliance of specified risk parameters and guidelines. The World Bank is currently reviewing the possibility for additional adjustments to shorten duration in the portfolios.
- 8. The following chart shows the details of allocation of cash balance of the Global Fund's trust fund in various tranches and the tranchewise investment return as of October 16, 2008, and illustrates the impact of recent market conditions on returns for the Global Fund Trust Fund.

- 9. The investment returns shown above are annualized for reporting purposes only and should not be construed as an investment return forecast for the remainder of calendar year 2008. The preliminary investment returns data for the period October 1, 2008 to October 16, 2008 show a significant drop in the overall investment returns for the Global Fund Trust Fund on an annualized basis compared to the rest of the year. The drop in the return is a reflection of the negative impact of the recent financial turmoil on the investment Pool.
- 10. The Trustee will provide a more detailed oral update during the meeting of the Board of Directors in New Delhi in November.
- 11. Grant commitments and disbursements are based on instructions received from the Global Fund. Both commitments and disbursements for project grants continue to increase. Commitments for project grants for calendar year 2008 through September 2008 were USD 1.71 billion representing an increase of 22% of the total commitments made through the end of calendar year 2007. Project disbursements during the first three quarters of calendar year 2008 were USD 1.38 billion representing an increase of 28% over the total disbursements made through end of calendar year 2007. Since inception, the Trustee has committed: (i) USD 9.51 billion<sup>3</sup> for project grants, of which USD 6.35 billion<sup>4</sup> has been disbursed to Principal Recipients<sup>5</sup> (see Annex III); and (ii) USD 570 million towards approved operating budgets, of which USD 529 million has been disbursed (see Annex IV). The following chart shows the project commitments and disbursements since inception to September 2008, on an annual basis.



12. Commitments and disbursements for project grants in EUR increased rapidly during calendar year 2008. Commitments for project grants for calendar year 2008 through September 30, 2008 were EUR 88 million representing 123% of the total commitments made during calendar year 2007. Project disbursements in EUR during the first three quarters of calendar year 2008 were EUR 58.7 million, representing 109% of disbursements made during calendar year 2007. From inception, the Trustee has committed EUR 284.16 million, and has disbursed EUR 156.92 million. Although project commitments in EUR represent approximately 4.36% of the overall project commitments of



the Global Fund, the level of EUR commitments have increased at a steady pace over the last several years. The Trustee continues to work closely with the Secretariat to determine the portion of the Trust Fund balance to be held in EUR to match project grant commitments in EUR. As of the date of this report, the amount of cash and promissory notes balance in EUR is above the amount required to cover existing approved commitments for EUR grants.

13. **Trustee operations** have expanded in line with the growth in the Global Fund's operations. In terms of the volume of transactions, as of September 30, 2008 the Trustee has received and processed 972 commitment and 3,369 disbursement requests. The following chart shows the pattern of steady increase in the volume of transactions since 2002 through September 30, 2008.



- 14. **Funds available for commitment** are based on contributions received by the Trustee, investment income earned in the Global Fund Trust Fund, signed grant agreements and approved operating budgets<sup>6</sup>. Table 2 provides the current status of funds available for commitment, including potential contributions receivable from existing signed contribution agreements and grant commitments in the pipeline. As of September 30, 2008, net funds available in the Trust Fund for commitment towards new project grants and other expenses equaled USD 2.17 billion and EUR 152.73 million, respectively. Net funds potentially available for commitment of new grants and operating expenses (including Board approvals) total USD 1.34 billion, taking into account:
  - (i) USD 380 million and EUR 418 million in pending contributions from existing signed contribution agreements;
  - (ii) USD 283 million in approved Round 1 through 7 proposals that have been signed into grant agreements but not yet submitted to the Trustee for commitment (i.e., the value of inprocess grant commitments); and
  - (iii) USD 1.75 billion in approved proposals for which the Secretariat is in the process of signing grant agreements with Principal Recipients (i.e., the value of potential commitments).

#### III. Other Financial Items

- 16. **Resource Mobilization**: There continue to be limited contributions from donors to the Global Fund in the form of promissory notes. To date, only France and the United Kingdom have paid their contributions to the Global Fund in the form of promissory notes. As of September 30, 2008 the outstanding promissory notes are EUR 150 million from France and GBP 40 million from the United Kingdom.
- 17. **Investment Income**: The Trustee, as a member of the Finance and Audit Committee (FAC), has been working closely with the FAC Working Group on Optimizing Investment Returns (the Working Group) in exploring investment management options to optimize investment returns in the light of increasing liquidity levels, consistent with best practices of publicly funded institutions. The Working Group identified a group of highly-qualified outside experts to advise it in its work, and presented the FAC with a number of recommendations, and an outline of its work plan going forward. The details of these discussions are contained in the report of the FAC to the Board of Directors.

## IV. Coordination and alignment between the World Bank and the Global Fund

18. There is enhanced coordination and alignment at the global and country levels. The World Bank and the Global Fund work together through various global mechanisms, including the Global Joint Problem-Solving and Implementation Support Team (GIST), the IHP+, the Monitoring and Evaluation Reference Group and Technical Working Groups, Roll Back Malaria, the Affordable Medicines Facility for Malaria, Stop TB, and others. The Bank co-chairs a UNAIDS working group on validation of national strategies (in which the Global Fund actively participates) to facilitate the Global Fund move to financing National Strategy Applications. In an increasing number of grantee countries, Bank and Global Fund teams are working closely together—for example—to ensure complementarity and coordinated program support, and to improve program management, monitoring and results, notably in Afghanistan, Honduras, India, Lesotho, Malawi, Rwanda, and Swaziland. The World Bank's Global HIV/AIDS Program Director was seconded to the Global Fund as Acting Director of Operations from November 2007 through the end of June 2008.
